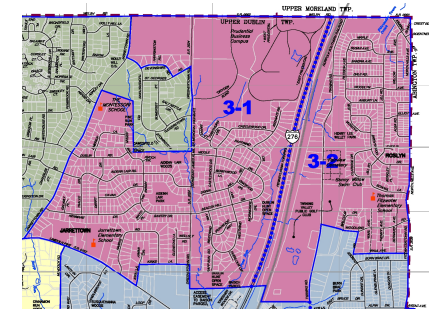

Real Costs of Services

Township vs. Privatizing Services

Township trash, yard waste, and recycling costs are approximately \$270 per year to the average home assessed at \$190,000. Private collection costs are on average \$320 per year. The seven township trash/recycling/yard waste trucks serve a dual purpose as snowplows, saving taxpayers money above and beyond trash collection.

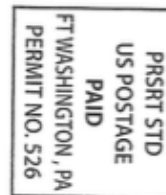
